

ORDINANCE NO. 3768

AN ORDINANCE AMENDING ORDINANCE NO. 3544, SEGREGATING THE LIENS OF WILLIAM DOLMYER, AND WILMER LONG ON PROPERTY DESCRIBED AS SS-71-2, 23RD AND JACKSON SANITARY SEWER, AND DECLARING AN EMERGENCY.

Whereas, William Dolmyer and Wilmer Long were assessed for sanitary sewer improvement under project SS-71-2, 23rd and Jackson Sanitary Sewer under Ordinance No. 3544 for the following properties:
