EASEMENT FOR PUBLIC UTILITIES

THIS AGREEMENT, made and entered into this 17 day of October, 1995, by and between Harold P. Benson and W. L. Hornberger, herein called Grantors, and the CITY OF ALBANY, a Municipal Corporation, herein called "City."

WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consists of:

A fifteen-foot wide easement for public utilities across that property described in MF 714, Page 412, Linn County Deed Records, The Point of Beginning of this easement is described as follows and is shown on the attached map labeled Exhibit "A".

Beginning at a point at the southeast corner of said MF 714, Page 412, Linn County Deed Records, said point being 1336.10 feet North 88°55'00" East and 4,259.38 feet South 00°06'00" West from the northwest corner of the Truett Davis Donation Land Claim Number 38 in Township 11 South, Range 4 West, of the Willamette Meridian, Linn County Oregon.

See attached map labeled Exhibit "A" for the centerline metes and bounds description of the fifteen foot wide easement.

2. The permanent easement described herein grants to the City, and to its successors, assigns, authorized agents, or contractors, the perpetual right to enter upon said easement at any time that it may see fit, for construction, maintenance, evaluation and/or repair purposes.
3. The easement granted is in consideration of \$1.00 and in further consideration of the public improvements to be placed upon said property and the benefits grantors may obtain therefrom.
4. The Grantors do hereby covenant with the City that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.
5. Upon performing any maintenance, the City shall return the site to original or better condition.
6. No permanent structure shall be constructed on this easement.

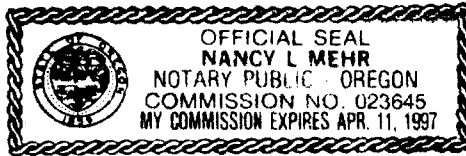

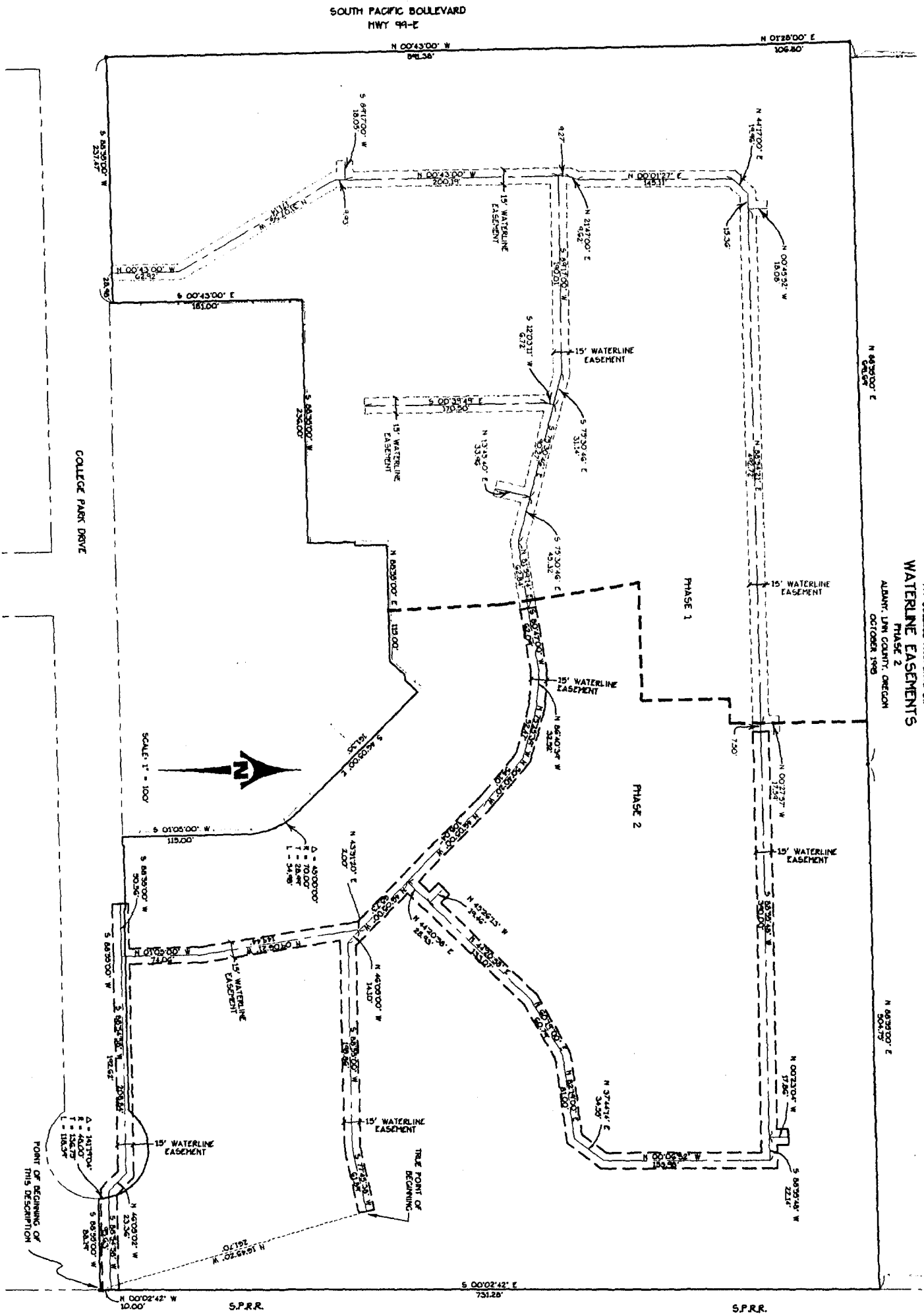
