


NOW, THEREFORE, BE IT RESOLVED by the Albany City Council that it does hereby accept these easements.

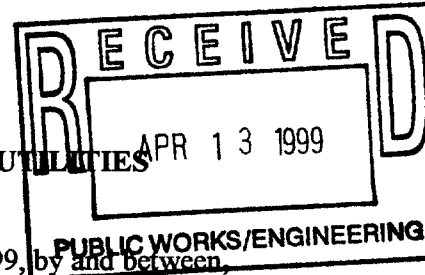

PERMANENT AND TEMPORARY EASEMENTS FOR PUBLIC UTILITIES

THIS AGREEMENT, made and entered into this 5th day of April, 1999, by and between, De Gui Lee Xiong and Lam Cheuk, herein called Grantors, and the CITY OF ALBANY, a Municipal Corporation, herein called "City."

WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

- 1. The right-of-way hereby granted consists of:

PERMANENT UTILITY EASEMENT

A permanent public utility easement across that property conveyed to De Gui Lee Xiong and Lam Cheuk, described in Volume 643, Page 042, Linn County Microfilm Deed Records, said easement being more particularly described as follows and as shown on the attached map labeled "EXHIBIT A".

A 10.0 foot wide permanent easement parallel, adjacent and south of the line described below and further shown on the attached drawing labeled "EXHIBIT A".

Beginning at the northeast corner of Lot 5, Block 1 of T.P. & E.L. Hackleman Addition to the City of Albany, Section 7, T.11S., R.3W., Willamette Meridian, Linn County Oregon; thence westerly, parallel with the southern boundary line of said block, a distance of 120.75 feet, and there terminating.

Containing 0.0277 acres of land, more or less.

TEMPORARY CONSTRUCTION EASEMENT

A temporary construction easement across that property conveyed to De Gui Lee Xiong and Lam Cheuk, described in Volume 643, Page 042, Linn County Microfilm Deed Records, said easement being more particularly described as follows and as shown on the attached map labeled "EXHIBIT A".

A 25.0 foot wide temporary construction easement parallel, adjacent, and south of the line described as follows: beginning at the northeast corner of Lot 5, Block 1 of T.P. & E.L. Hackleman Addition to the City of Albany, Section 7, T.11S., R.3W., Willamette Meridian, Linn County Oregon, thence westerly, parallel with the southern boundary line of said block, a distance of 120.75 feet, and there terminating.

2. The permanent easement described herein grants to the City, and to its successors, assigns, authorized agents, or contractors, the perpetual right to enter upon said easement at any time that it may see fit, for construction, maintenance, evaluation and/or repair purposes.

The temporary easement described herein grants to the City, and its authorized agents or contractors, an irrevocable right to enter upon said easement at any time within a period of twelve (12) months from the date of this instrument, for construction, repair, evaluation, or maintenance purposes.

3. The permanent and temporary easements are in consideration of \$1.00, receipt of which is acknowledged by the Grantors, and in further consideration of the public improvements to be placed upon said property and the benefits grantors may obtain therefrom.

4. The Grantors do hereby covenant with the City that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.

5. Upon performing any maintenance, the City shall return the site to original or better condition.

6. No permanent easement shall be constructed on the 10-foot permanent easement.

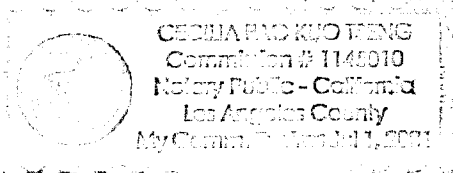

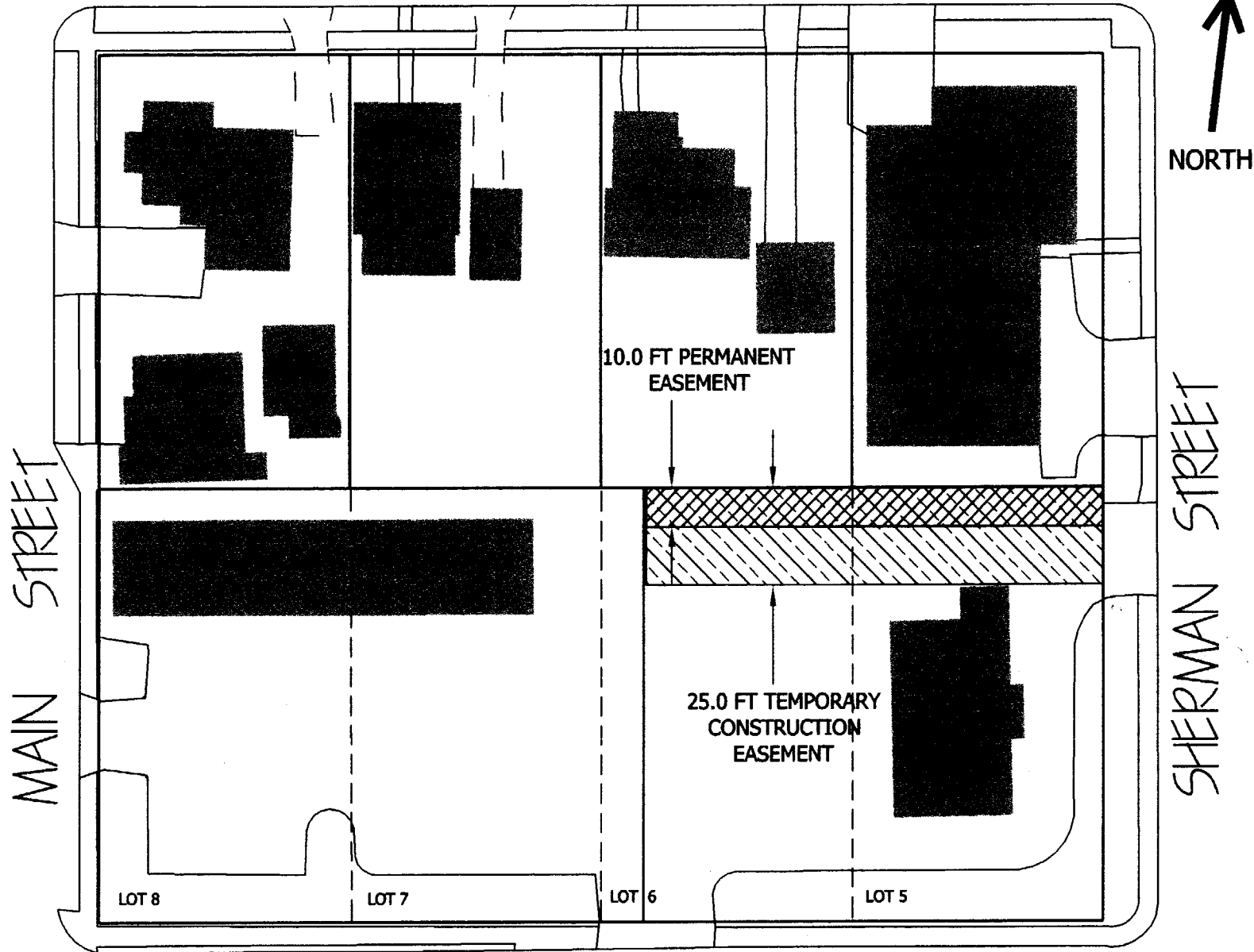
