A RESOLUTION ACCEPTING TRANSFER OF JURISDICTION OF A PORTION OF NW HICKORY STREET, COUNTY ROAD NO. 14401, FROM BENTON COUNTY.

WHEREAS, the construction was completed and accepted for project SI-99-17, Hickory Hills, in July 2000; and


WHEREAS, the portion of Hickory Street improved to City standards lies west of North Albany Road; and

WHEREAS, the Benton County Board of Commissioners has by Order No. D2000-093, recorded as document M 287041-00, initiated the transfer of jurisdiction of said portion of Hickory Street; and

WHEREAS, the City of Albany wishes to accept the jurisdiction for said portion of Hickory Street.

NOW, THEREFORE, BE IT RESOLVED that the City Council hereby accepts jurisdiction for the portion of Hickory Street lying west of North Albany Road.

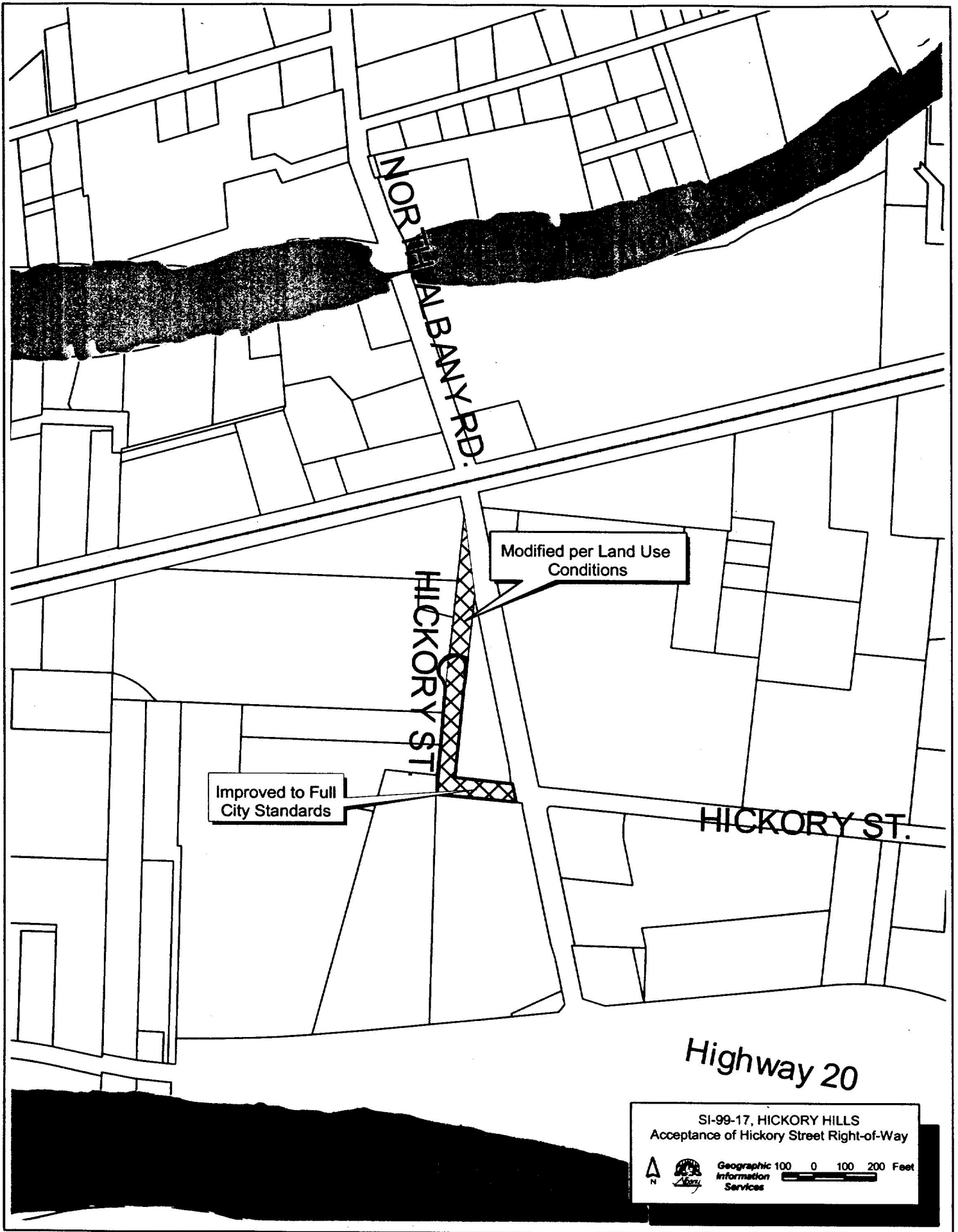

IT APPEARING TO THE BOARD

THAT; pursuant to ORS 373.270, the order initiating transfer of jurisdiction of a portion of NW Hickory Street, County Road No. 14401 to the City of Albany has been recorded in M-285481-00, Benton County deed records, and

THAT; pursuant to ORS 373.270 (2a) notice has been posted in three (3) public places; and

THAT; pursuant to ORS 373.270 (4) a public hearing was held on the 1st day of August at 12:00 noon in the Benton Plaza Meeting Room, 408 SW Monroe, Corvallis Oregon.

NOW, THEREFORE, THIS BOARD FINDS that it deems necessary, and in the best interest of the County to surrender jurisdiction of a portion of NW Hickory Street County Road No. 14401, over to the City of Albany.

NOW, THEREFORE, IT IS HEREBY ORDERED that the County surrender jurisdiction to the City of Albany a strip of land located in Section 1, Township 11 South, Range 4 West, Willamette Meridian, Benton County, Oregon, described as follows:

All of NW Hickory Street (County Road No. 14401) lying West of North Albany Road (County Road No. 14400).


NOW, THEREFORE, IT IS HEREBY ORDERED that the City of Albany has until December 1st, 2000, to adopt appropriate municipal legislation accepting said County road, and if this action has not been approved by December 1st, 2000, the County shall retain jurisdiction.
