A RESOLUTION ACCEPTING THE 2001-2002 LINN COUNTY SPECIAL TRANSPORTATION FORMULA PROGRAM INTERGOVERNMENTAL AGREEMENT FOR THE ALBANY CALL-A-RIDE, ALBANY TRANSIT SYSTEM, AND LINN-BENTON LOOP TRANSIT SYSTEM FUNDING.

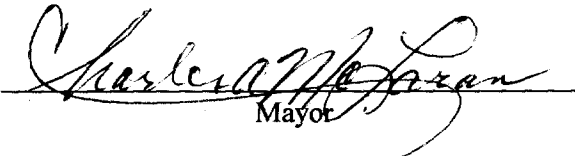
WHEREAS, the City of Albany has submitted 2001-2002 Special Transportation Formula (STF) funding support applications to Linn County for the Albany Call-A-Ride, Albany Transit System, and Linn-Benton Loop Transit System; and

WHEREAS, the City of Albany is the service provider for the Albany Call-A-Ride, Albany Transit System, and Linn-Benton Loop Transit System.

NOW, THEREFORE, BE IT RESOLVED that the City of Albany accepts the Linn County STF intergovernmental agreement in the amount of \$23,000 for operating expenses for Albany Call-A-Ride, \$7,500 for Linn-Benton Loop, and \$400 for Albany Transit System for fiscal year 2001-2002; and

BE IT FURTHER RESOLVED that the City Council of the City of Albany, Oregon, accepts these funds and authorizes the City Manager to execute the agreements and conditions for their acceptance.
