

RESOLUTION NO. 4494

Final Engineer's Report

Action Requested:

Staff requests that Council accept the Final Engineer's Report and Financial Investigation Report and adopt the attached resolution to schedule a public hearing for October 10, 2001. Final project costs and distributions of the final assessments for the Lehigh/Riderwood Access Local Improvement District (LID) will be considered.

Background:

The need to provide an alternative access for this neighborhood area was an ongoing issue for many years. Development of this area was initiated with the first phase of the Lehigh Acres Subdivision in 1951, with Highway 20 being the sole access for the entire area. As additional subdivisions were developed and the neighborhood area grew in the 1950s and 1960s, traffic volumes continued to increase so that safety of area residents negotiating turns to and from Highway 20 became a concern.

Development of the Riderwood Subdivision began in 1991, prompting area residents to again ask about an alternative access. In response, Council directed staff to investigate the connection of 14th Avenue to 16th Avenue in 1992, but it was not pursued due to lack of neighborhood support. However, with continued requests for an alternative access and concern for the safety of residents having no access other than Highway 20, Council directed staff in 1997 to reexamine the options to connect 14th Avenue to 16th Avenue.

The City Council reviewed options with staff and decided to connect 14th Avenue to 16th Avenue with a smooth, reversing curve. It was recognized that creation of the right-of-way for this alignment would severely impact two intervening parcels. The City Council shared the general neighborhood's concern for the owners of those two parcels, and offered to purchase the properties. Negotiations were conducted to purchase both parcels, which were amenable to all parties and were concluded during summer 1999.

The LID formation was finalized in January 2000 and the project design was completed. The construction contract was awarded and constructed in summer 2000, with final payment made in March 2001.

Discussion:

The construction contract was awarded to Alton E. Sullivan Construction, Inc., of Albany, Oregon. The street improvements connected 14th Avenue to 16th Avenue, and extend north on

Shortridge Street approximately 100 feet. Bike lanes and sidewalks were installed along the new street with the bike lanes being extended to Waverly Drive to provide a connection to the City's bicycle network. Storm drainage was routed to the south on 17th Avenue and connected to the existing interceptor line running through Lehigh Park.

The new water line construction greatly enhanced the area water system, connecting the previous dead-end lines on 14th and 16th Avenues and on Shortridge Street. Sanitary sewer service was stubbed out to the reconfigured properties so that all properties having frontage on the new street are now fully served by City utilities.

The LID boundary, new street alignment, and reconfigured parcels are shown on the attached map, with the individual property assessments calculated on the attached assessment computation sheet and detailed in the Financial Investigation.

Cost Summary:

The total final project costs, including property acquisition, engineering, legal, and administration fees amount to \$689,725.34. This amount is approximately 9 percent below the estimated total project cost of \$760,000 presented in the initial Engineer's Report when the LID was formed. A comparison of the initial estimated project cost and final total project cost is shown below.

It was initially planned for the City to credit proceeds from the resale of acquired property to reduce the net assessable project costs, which were assumed to be equal to the cost of acquiring the property. The result was that the estimated assessments reflected project construction costs only. At this time the City is in the process of obtaining bids to sell the two remaining City owned parcels, but the process has not yet been concluded.

As shown below, there are no land sale proceeds to offset the acquisition cost at this time. Therefore, property acquisition costs have been assessed against the parent parcels as shown on the assessment computation sheet. Using this strategy, the final assessments on the privately owned parcels adjacent to the new street will be for construction costs only. This total amount is \$372,953.16, approximately 14 percent below the estimated assessable construction cost of \$435,000.

Method of Assessment:

In the early stages of this project, staff and Council held several meetings with area property owners prior to forming the LID. During this process the City Council agreed to hold the unit assessments for the large neighborhood area (non-fronting properties) to a fixed amount of \$715 per lot. This amount was the per lot assessment originally proposed in 1992 and was locked in so that it would not increase or decrease at the time of final assessments. As shown on the assessment computation sheet, this amount has been maintained for the 329 non-fronting parcels within the large LID area.

The Council was concerned with the assessment to the large lot owned by Mary and Dennis Larsell. To maintain equity in the assessment methodology it was decided to exempt the front portion of the lot that took access from Shorridge Street, and the rear portion where 14th Avenue had been previously improved. The intent was to only assess the portion of the lot that would have frontage on and take access from the new construction. Under this methodology, the estimated assessment was reduced to \$68,388.87.

The Larsell property has since been purchased by Firstmark, Inc. Firstmark also purchased a narrow ten-foot-wide strip of excess City-owned property between the Larsell parcel and the new 14th Avenue right-of-way, with those proceeds being credited back to the project. Firstmark then adjusted the lot lines to separate the original Larsell parcel into two lots. The east lot now has frontage only on Shorridge Street, and the west lot now has frontage only on 14th Avenue. While the final lot line configuration is slightly different from the City's initial attempt to identify the assessable portion of the original parcel, the result is identical to the Council's intent. Following the initial methodology, the final assessment is \$49,382.95, approximately 28 percent below the initial estimate.

After adjusting the lot lines to create new street right-of-way, the remaining parcels to be assessed for frontage improvements are most equitably assessed on an area basis. This is consistent with the methodology adopted when the LID was formed. The construction cost assessments consist of a street and storm drain component and a water line component as shown on the assessment computation sheet.

Several property owners have asked for the LID to be closed out so that they may pay off their assessment and remove the lien from their property. The City would also benefit from closing out the project because assessment payments will be collected to start paying off the project cost. However, as discussed above, the acquired property has not yet been resold and proceeds credited to the project.

To facilitate the LID close out, the property acquisition costs have been assessed against the two parent parcels as shown on the assessment computation sheet, which are still owned by the City. Staff recommends that the Street Fund assume all assessments on the two remaining City-owned parcels until the property is resold, with all proceeds then being credited back to the Street Fund. This strategy will allow the LID to be closed out promptly, maintain the original goal of assessing private property owners for construction costs only, and provides immediate cost recovery for the City's Street Fund as soon as the property is resold.


Budget Impact:

Staff recommends that this project be funded in the amount of \$689,725.34 from the Improvement Projects Fund (26-985), which will be recovered through a combination of assessments to the benefiting neighborhood area and adjacent privately-owned properties.


If approved by Council, \$401,460.85 will be assessed to the two City-owned parcels and semi-annual payments will be made from the Street Fund (03-410) until the parcels are sold. At closing, adjustments will be made to pay all remaining pending assessments and/or credit the proceeds to the Street Fund to reimburse it for assessments paid.


Adjacent Benifitted Areas

Section 3. Number of similar lots and property held by the City through foreclosure.

The City is not holding any properties obtained through foreclosure. Less than 20 properties are delinquent more than one year.

Section 4. Delinquency rate of assessments and taxes in the area.

Ninety-seven percent of City assessments are current. Property tax collections remain constant at 95 percent of current taxes levied.

Section 5. Real estate value trends in the area.

Real estate values within the City remain high. Building activity remains strong, however this is expected to decrease during FY 1999-2000.

Section 6. Tax levy trends and potential financial impact on the proposed LID.

Taxes will remain stable. A small increase should be expected from the Streets General Obligation Bond and from the anticipated three percent property value increase limit.

Section 7. Does the project conform to the City Comprehensive Plan.

This project conforms to the City's Comprehensive Plan.

Section 8. Status of City's debt.

If the proposed local improvement districts (LID) are approved, there is a potential for several LID borrowings in 1999-2000. LIDs for 53rd Avenue, Grand Prairie, and several smaller consolidated projects are being considered.

Section 9. Estimated cost of financing.

The City's practice is to charge property owners two percent more than the interest rate on bonds to pay for the costs associated with billing the property owners. If the assessment bonds sell at seven percent, then the property owners will pay nine percent.

Section 10. General credit worthiness of property owners within the LID.

This is a well-established neighborhood with houses on most lots. The lots are owned by many individuals. These assessments represent about one-half of one percent of the value of the property.
