



RESOLUTION NO. 7029

A RESOLUTION REPEALING CERTAIN RESOLUTIONS NO LONGER RELEVANT OR IN FORCE.

WHEREAS, the evolution of laws and City functions may make previously useful resolutions irrelevant or outdated; and

WHEREAS, it is reasonable to repeal resolutions that have been superseded by state statute or that are no longer useful; and

WHEREAS, it is not an effective use of staff time to search the record for such resolutions; so staff from the city manager's office has kept a running list, updating it when a new one is found; and


WHEREAS, all of the resolutions on the list are housekeeping in nature and inconsequential, and the departments responsible have confirmed that they are no longer valid; and

WHEREAS, the last time the city council adopted a resolution for mass repeal was in 1982 by way of Resolution No. 2309; and

WHEREAS, city staff have reviewed each of the resolutions in Exhibit A and determined that they are no longer used to conduct City of Albany business.

NOW, THEREFORE, BE IT RESOLVED that the Albany City Council repeals the resolutions listed in Exhibit A.
